SECRETARY

PRESIDENT

MCANJ 2016 ANNUAL EDUCATION CONFERENCE

President Kazmark stated that the conference program has been posted on the website and there are 190 registered to date.

IIMC REGION II CONFERENCE

President Kazmark thanked Alan Susen and committee for coordinating the IIMC Region II Conference. A donation of \$1,000.00 was received from Delaware and the Executive board would be deciding if that money is to be retained or forwarded to the host of the IIMC Region II conference. The program financials show a profit of approximately \$3,000.00.

CONSTITUTION /BYLAWS

Eileen Gore reported the following report;

REPORT
CONSTITUTION AND BY-LAWS COMMITTEE

The committee has submitted proposed changes to the Constitution and By-laws with regard to the following Articles:

Article III - Officers

It has been proposed that wording be amended to reflect that the officer with the exception of Secretary shall automatically ascend to the next highest office following the completion of their current term so long as each individual shall continue to meet the qualifications. A Notice of Intent will stand to serve as their intention to continue to service or vacate their eligibility to serve at the next highest position. The office of Secretary shall continue to be elected by ballot annually unless otherwise provided.

The definition of Treasurer and Secretary was amended to reflect current times.

The Resolutions Committee was also changed to require resolutions be provided to the secretary for inclusion in the minutes of the Annual Meeting.

Article IV - Elections

It was determined to remove to phrases such as 120 or 90 days to that of a more definitive yearly date. Due to the changes in Article III, Officers, it was required that additional 'cleanup' wording be done in order to reflect correctly.

Article VII – Vacancy on Executive Board

It was felt that the definition of a 'Vacancy' needed stronger language, and 'Removal' was added to effectuate a procedure for same.

These proposed changes will appear in the next issue of the *The Quill* and will be voted upon by the membership at the 2016 Annual Business Meeting.

2nd VICE PRESIDENT

Dina Zawadski, 2nd Vice President, announced that she is accepting MCANJ Education Conference registrations and beginning to work on the education sessions for the NJSLOM November conference.

IMMEDIATE PAST PRESIDENT

John Mitch, Immediate Past President, reported that he and Denise Szabo, First Vice President, are working on the updating of the Bylaws. Discussion ensued on the definition of unexcused absences for members of the Executive Board and the timeliness of written notification submission for an excused absence.

OPRA/OPMA/GRC UPDATE

President Kazmark reported that OPRA/OPMA legislation has been re-introduced S1046 (OPRA) and S1045 (OPMA). Attorney Goodell commented how the new legislature addresses the commercial vs personal request for public information. The proposed legislature would be disseminated to all Advisory Board members.

RMC EXAM RESULTS

President Kazmark reported the following RMC exam results;

October 2015 69% pass rate

April 2016 59% pass rate.

The pool of questions was reviewed with Dan Kaminski, Certification Director, DLGS. The result of that meeting was to make six questions more clear.

RUTGER'S

President Kazmark informed everyone that Rutgers University CGS Education Committee has reviewed the instructor requirements to include MCANJ in the review of instruction resumes. It was reiterated that an instructor must of a minimum of five years employment as a Municipal Clerk.

EXECUTIVE DIRECTOR

LEGAL DEFENSE FUND BY-LAW CHANGE PROPOSALS

Joel Popkin, Executive Director stated that the LDF Bylaws require grammatical review with an amended effective date of 1 July; elimination of a 7 member committee; creation of a 3 member committee; and, a change of dates to accommodate the fiscal year. Mr. Popkin explained that the role of PDF has changed to review the completeness of an application. The Executive Board will review this proposal prior to the Annual Meeting. The proposed amendments are;

2. Method of Appointment

A. The Committee shall be appointed by the MCANJ President with the approval of its Executive Board and shall be constituted as follows:

Chairperson who is a member of the Legal Defense Fund.

~~Regular members - Three (3) Seven (7) tenured Municipal Clerks who are members of the Legal Defense Fund, regular members in good standing of the Legal Defense Fund, two (2) from each of the three zones, if practicable, (North, Central and South) and one (1) active or retired past president of the MCANJ who will act as Chair of the Committee.~~
~~Alternate members - One (1) three (3) alternate members in good standing who is a member of the Legal Defense Fund, one (1) from each of the three zones (North, Central and South). Only one member can be appointed from any county.~~
~~The North, Central and South Zones are defined as follows:~~

- ~~(a) Northern Counties Bergen, Essex, Hudson, Morris, Passaic, Sussex and Warren.~~
- ~~(b) Central Counties Hunterdon, Mercer, Monmouth, Middlesex, Somerset, Union and Ocean.~~
- ~~(c) Southern Counties Atlantic, Burlington, Camden, Cape May, Cumberland, Gloucester and Salem.~~

5. Eligibility for Financial Assistance

A. Eligible member shall be a Municipal Clerk, Acting Municipal Clerk, Deputy Clerk, Freeholder Clerk or Deputy Freeholder Clerk who is a current member in good standing of MCANJ ~~in the fiscal year prior to the year of the application.~~

7. Legal Expenses

A. The LDF shall pay a member for legal fees paid by the member to the member's attorney in an amount not to exceed \$7,500.00 subject to the \$500 deductible as set forth in ~~8-7~~ as follows:

B. The LDF shall make payments as required up to \$7,500.00 upon the presentation of a statement of fees and costs relating to the matter in which the member is to receive payment as set forth in ~~DE~~. The statement shall be reasonably detailed to set forth the legal services rendered and to indicate that they relate to the underlying action which is the subject matter of the request

for payment from the LDF.

8. Deductible Amount

A. There shall be a deductible amount of \$500.00 per application.

13. Effective Date

The effective date of these by-laws is: ~~October 24, 2014~~ December, 2015

CONSTITUTION & BYLAWS

EDUCATION COMMITTEE

A prepared report was received from Joanne Kwasniewski, stating the following;

The Education Committee worked very hard to create descriptions for the sessions to be held at the MCANJ Annual education Conference. They have been asked to convene or be a scanner at those sessions.

As Chair of the education Committee I attended Rutgers Educational Advisory Committee and Instructors meeting. It was a very productive meeting at which Dan Kaminski introduced Shannon Hudak who will be replacing him upon his retirement. The October 14, 2015 exam results were reviewed with a 50% passing rate which was a little less than the 59% passing rate for the April 2015 exam. Rutgers will schedule a pre-conference session prior to the MCANJ education conference. Rutgers is exploring the feasibility of offering a MCM Academy 3-day session in September. More information will follow once the details are worked out.

MINI CONFERENCE SOUTH

Pat Frontino submitted the following report;

We anticipate another successful Mini Conference South, which will be held on Friday, March 11th. Again, we have reserved the Deptford Recreation Center for our venue. Our panel of speakers is William J. Perna, Sr. County Detective, Gloucester County Prosecutor's Office, Kim-Marie White, RMC/CMC, Eastampton Township Municipal Clerk, Michael D. Cesaro and Evan J. Palmer, Auditors from Bowman and Company, and Christine Donahue, Investigator, Legalized Games of Chance Control Commission. As of this date, there are 93 people registered. The day begins with Registration and breakfast at 8:00 A.M. Two sessions are scheduled for the morning, then we break for lunch from 12:00-12:30. Two additional sessions will be held in the afternoon before the day concludes at 4:00 P.M. ELECTIONS

The following report was received from Linda Wanat.

The committee (along with the rest of our nation) is gearing up for a busy "election season". For most of us that means a minimum of two: primary and general with possibly a municipal, school, fire district, and referendum or recall election thrown in the mix.

One area of concern has been the discontinuation of the petition module from the SVRS. While Municipal Clerks still have the ability to determine if an individual is a registered voter and can identify a signature, the program no longer provides for information regarding duplicate petitions

for the same office or running tally's. Although these functions were helpful in the past we were told that they were not utilized by most Municipal Clerk's and were eliminated.

A representative of the SVRS indicated that the entire system is being modified and that training is available to all counties by calling 1.866.456.9406.

In addition to extending elections from one to 15 days, the bill would permit online voter registration, automatic voter registration through the Dept. of Motor Vehicles, pre-registration for 17 year-olds, and lower population threshold for publishing election materials in languages other than English.

On October 8th the Essex County Municipal Clerk's Association will host Assemblyman Tom Giblin, co-sponsor of the bill, at a seminar at the Verona Community Center, 1:30 – 3:00 pm. For more information please call Linda Wanat at 973.509.4900. Also on the program will be Essex County Clerk Christ Dunkin who will address polling locations in the event that the "early Voting" legislation passes.

Members of the Election Committee have been actively sharing news articles regarding number of issues including voter identification laws, exclusion of voters with criminal records and Election Day registration. It appears to be a definitive period for elections in NJ. We will continue to monitor any actions.

FUND RAISING

Doreen Cali reported the on-line sale of MACNJ merchandise has been very successful.

INFORMATION TECHNOLOGY/WEBPAGE/FACEBOOK

Drew Pavlica indicated that the MCANJ Facebook site has 459 likes and he posts three articles daily. He reminded everyone to forward their County Association information so it may be included.

LEGAL DEFENSE FUND

Sharon Brienza submitted this report;

One case that had been going on for more than two years was finally settled. The Municipal Clerk did very well and their municipality was required to pay her legal fees.

I received a telephone call from a Municipal Clerk last week. She has only been in the position for a little more than a two years and she is having problems. One of the issues is the Tax Collector, Assessor and CFO getting raises where she is not. She is of course familiar with the statute. I told her she should speak to an attorney, complete the LDF application and submit to me. She said she had just completed the application for membership and sent it in. At that point I had to tell her about the 90 days waiting period. I also suggested that she speak to an attorney because sometimes all it takes is a letter or two to get situations resolved. If this happens in her case, it could cost less than the \$500.00 deductible. She said she didn't want to make waves since she's up for reappointment next year. I asked her to keep me informed on what happens.

Harold Wiener reported the following;

I am unsure if Sharon issued a report from the Legal Defense Fund Committee. I know two issues that may have been raised are mandatory attendance of the Municipal Clerk at Executive Sessions and the statutory language regarding pay increases for certain licensed professionals in local government.

President Kazmark and/or Attorney Lustgarten may be touching base on these materials.

MANUAL REVIEW COMMITTEE

Denise Szabo confirmed that she shall be reviewing the Records section of the manual to reflect current records technology.
